#### Wristband Policy

NAFF, Inc. requires any Festival attendee interested in purchasing and/or consuming alcoholic beverages to purchase and wear an Adult Beverage Wristband. This wristband signifies that an approved Festival Committee member or volunteer has checked the wearer's identification and that the wearer is of legal age to buy and/or consume alcohol.

Adult Beverage Vendors will **not** be required to ask for identification for any customer displaying a wristband. Please redirect any patron not wearing a wristband to the wristband table. A Festival Map will be provided for your convenience.

#### ADHERENCE TO THIS POLICY IS MANDATED BY THE INDIANA BOROUGH PERMIT AND PLCB OPEN CONTAINER GUIDELINES.

#### Festival Guidelines:

Approved vendors will be granted a 10' x 10' space. All return vendors will be given the same space as in previous festivals, unless other arrangements have been made. The 2024 Northern Appalachian Folk Festival will be adding a Community Stage in front of the First Commonwealth offices by Carpenter Avenue. If your space is in this area, we will accommodate your requests.

All approved vendors are agreeing to **BOTH** days of the festival.

Vendor booths **must** stay open until at least 7pm of each festival day regardless of weather conditions. Come prepared. Booths should be designed to handle all kinds of weather. In the event of inclement weather, the Festival Committee will determine the appropriate actions to be taken.

All trailers and personal vehicles must remain in designated vendor parking areas until the Festival ends.

Spaces **may NOT** be shared with any non-applicants.

Vendors must provide all equipment and materials necessary for exhibition, including tent, tables, chairs, skirting, lighting, etc.

A roll-off dumpster will be available in the parking lot across from the Indiana Fire Department to dispose of excess trash. There will be garbage containers throughout the Festival grounds, and will be managed by a local civic organization.

# Failure to comply with these guidelines will affect future participation in this event.

#### Set-up times:

Streets will be closed at 9am on Friday, September 6, 2024 for stage set-up.

Vendor set up will begin at 12 Noon on Friday, September 6, 2024, and must be ready to sell/exhibit by 4pm at the official start of the festival.

Vendors can restock between 8am - 12 Noon, on **Saturday, September 7, 2024**, but **NO** vehicles will be permitted to enter the festival area. Please plan in advance how to transport needed items.

Sales can begin as early as 10am during the "Walk of Fame" presentations in front of Spaghetti Benders, but must be open at 12 Noon for sales.

#### Vendors may stay open both nights until 10pm, but MUST stay open until 7pm. Security will be on hand at all times.

NAFF, Inc. will display signs for specified vendor parking and there will be a vendor check in upon arrival for set-up. All questions should be directed to Judy Holliday at judy@naffinc.org.
